Druker Speaks on GMO Risk and Illegality Sept 2

SAN DIEGO (Sept 1, 2015) -- Steven Druker, attorney and author of “Altered Genes, Twisted Truth” will speak at the La Mesa Community Center on Wednesday Sept. 2, with doors opening at 6:30pm and the event starting at 7pm. His talk, entitled “Why Genetically Engineered Foods Are Unacceptably Risky and Unequivocally Illegal – and Why Most People Are Utterly Unaware of It” is open to the public.

David Schubert, PhD, Molecular biologist and Head of Cellular Neurobiology, Salk Institute for Biological Studies, will provide introductory remarks. “This incisive and insightful book is truly outstanding,” Schubert said. “Not only is it well-reasoned and scientifically solid, it's a pleasure to read - and a must-read. Through its masterful marshalling of facts, it dispels the cloud of disinformation that has misled people into believing that GE foods have been adequately tested and don't entail abnormal risk.”

Druker's book is an eye-opening exposé of how genetic engineering entails human health risks that are not posed by natural plant breeding and how a large number of eminent scientists and scientific institutions have systematically misrepresented those risks. The FDA became an accomplice to the deception and enabled GE foods to come to market by covering up the warnings of its own scientists, lying about the facts, and deliberately violating federal food safety law.

Druker filed a federal case against the FDA against their policy of accepting all Genetically Modified foods as "Generally Recognized as Safe" (GRAS) and uncovered the truth behind our modified foods.



A march earlier this year in Balboa Park held by MAMSD had more than 1500 people protesting which also highlighted lawsuits by the City of San Diego and the Port District against Monsanto for polluting the bay. We are particularly appreciative of the La Mesa Foothills Democratic Club in providing the venue for the event.

Event organizer Ray Lutz of Citizens Oversight said, “I had heard that there was a scientific consensus

that GMO foods are safe. But when I really started to investigate, I found that these foods have no mandatory testing regimens. The FDA relies on Monsanto and other seed producers to guarantee their safety. Unfortunately, no long-term animal feeding studies are included. They rely on a 1992 policy pushed into fruition by then Vice President Dan Quayle which says that all GMO foods are inherently safe unless proven otherwise. It took us 100 years to realize that trans-fats are bad for your health. Let's not make that mistake again with GMO food. We must have mandatory robust testing for each transgenic variety.”

STEVEN DRUKER -- BIOGRAPHICAL SUMMARY

Steven Druker is a public interest attorney who, as executive director of the Alliance for Bio-Integrity, initiated a lawsuit that forced the FDA to divulge its files on genetically engineered foods. This revealed that politically appointed administrators had covered up the extensive warnings of their own scientists about the unusual risks of these foods, misrepresented the facts, and then ushered these novel products onto the market in violation of explicit mandates of federal food safety law.

He is recognized as an expert on issues regarding the risks and the regulation of GE foods and has served on the food safety panels at conferences conducted by the National Research Council and the FDA. He has also lectured at numerous universities (including the Biological Laboratories at Harvard, Tel Aviv University, and the University of Copenhagen) and met with government officials world-wide, including the UK's Environmental Minister and the heads of food safety for the UK, France, Ireland, and Australia. He was also invited to confer at the White House Executive Offices with an interagency task force of President Clinton's Council on Environmental Quality.

His articles on GE food have appeared in several respected publications, including *The Congressional Quarterly Researcher*, *The Parliament Magazine*, and *The Financial Times*.

He majored in philosophy at the University of California, Berkeley, received a special award for "Outstanding Accomplishment" in that field, was elected to Phi Beta Kappa in his junior year, and graduated with "Great Distinction in General Scholarship." He also attended UC Berkeley's law school, where he was elected to both the California Law Review and the Order of the Coif (the legal honor society).

His new book, *Altered Genes Twisted Truth: How the Venture to Genetically Engineer Our Food Has Subverted Science, Corrupted Government, and Systematically Deceived the Public*, was released in March with a foreword by Jane Goodall hailing it as "without doubt one of the most important books of the last 50 years." Among the other scientists who have also praised it highly are David Schubert, a professor and laboratory director at the Salk Institute for Biological Studies, who has called it "incisive, insightful, and truly outstanding"; and Joseph Cummins, Professor of Genetics at Western University, London, Ontario, who has lauded it as "a landmark" that should be "required reading" in every university biology course.
